ARTICLES OF INCORPORATION
OF
ORLANDO METROPOLITAN BRIDGE CENTER, INC.

ARTICLE I - NAME

The name of this corporation is ORLANDO METROPOLITAN BRIDGE CENTER, INC.

ARTICLE II - DURATION

This corporation shall exist perpetually, commencing on the date these Articles are filed with the Secretary of State.

ARTICLE III - PURPOSE

This corporation is organized under Chapter 617, Florida Statutes, as a corporation not-for-profit. This corporation has been organized for the specific purpose of promoting duplicate bridge in and around Orlando, Florida. To this end, the corporation shall have the power to own and lease any facilities at which duplicate bridge games or bridge instruction shall take place, to apply for and acquire a license from the American Contract Bridge League to operate as a licensed bridge club, and shall do all things incident to the carrying out of its aforesaid purposes.

Upon dissolution or liquidation of the corporation, all assets of the corporation shall be contributed to one or more organizations to further the purposes for which this corporation was formed.

ARTICLE IV - MEMBERSHIP

This corporation shall not be authorized to issue shares of capital stock, but it shall be organized on a membership basis. The qualification and manner of admission of members of the corporation shall be as set forth in the By-Laws of the corporation.
